- 1 The contest will be held from **23:00GMT on 22nd November Sunday** until **20:35GMT on 30th November 2015 Monday**.
- 2 The registration period is open until 30th November 2015.
- 3 In order to participate in the Trading Contest you are required to meet the following conditions:
 - 3.1 You must have an active LION Binary Options Account with us (if you do not have one please apply for an Account [HERE](#)).
 - 3.2 Only one (1) application per person is permitted for the Trading Contest. In the event that you make multiple Trading Contest applications only your first application will be valid.
 - 3.3 Apply for the Trading Contest by filling in [registration form](#) before the trading contest ends (20:35GMT on 30th November 2015). If you apply after the Trading Contest has started, any opening trades made after the time of application will be applicable for the Trading Contest.
