50% Deposit Bonus Campaign
Terms and Conditions

1. In order to participate in the 50% Deposit Bonus Campaign, you agree to be bound by these Terms as well as the general terms and conditions that apply to your Account. These Terms constitutes the entire Terms and extinguishes all previous Terms, promises, assurances, and understandings whether written or oral, relating to its subject matter.
2. You are required to be over eighteen (18) years old and have a Live Binary Options account with Hirose Financial MY.
3. We reserve the right to amend these Terms at any time without prior notification. Such amendments shall become effective and in force immediately upon being posted in this Terms section of our website. It is your responsibility to review the Terms on a regular basis (particularly in the end of a calendar month when we periodically update the Terms).
4. This program will run from 00:00 GMT on 01st October 2020 until 24:00 GMT on 31st October 2020.

Bonus Credit Related Conditions

5. For customers who have not previously received any deposit bonus from us, you will be entitled to the 50% deposit bonus when you make a deposit into your Binary Options account during the campaign period. The maximum bonus granted to you is \$1,000 (£1,000). Any amount of deposits over \$2,000 will be given a \$1,000 bonus. (A funds transfer from another trading account into your Binary Options account will be not be counted.)
6. The 50% deposit bonus will not be given to you if you have made a withdrawal of any amount from your Binary Options account before we process the credit of the bonus into your Binary Options account. Also, this bonus will not be given to you if you make a deposit right after the withdrawal for the purpose of receiving the 50% deposit bonus.

How to Receive a Bonus

7. In order to receive a 50% Deposit Bonus, you are required, during the campaign period to:
 - 1) Hold a LIVE Binary Options account with Hirose Financial MY. If you do not have the account, you can apply for the Live Binary Options account by filling in and submitting the account opening form along with the supporting documents.
 - 2) Fill in the Campaign Registration form and submit to us.
 - 3) Within 7 days of submitting the Campaign Registration form to us make at least \$50 (£50) deposit into your Binary Options account. Our payment methods can be found at <https://hiroseuk.com/lionbo/payment/deposit.php>.

- 4) The Bonus will be reflected to your account within 1-2 business days of a date on which you have made a deposit into your Binary Options account provided that you have already applied for the 50% deposit bonus by Campaign Registration Form.

Withdrawal Related Conditions

Q. Can I withdraw the bonus?

8. The Bonus can be withdrawn at any time after you have completed the trading requirement below.

Trading Requirement: 20 x Your Deposit Amount

For example:

You make a deposit of \$100 and receive \$50 as a 50% deposit bonus. You have completed (20 x \$100 = \$2,000) trading volume. Now you can withdraw the bonus at any time.

Q. Can I withdraw my profits and deposit amount?

9. Profits and your deposit amount can be withdrawn at any time. Please note the following conditions.
 - 1) If you wish to withdraw your profits and deposit amount **after** having completed the trading requirement of 20 times of your deposit amount, you will be able to withdraw all the funds including your Profits, Deposit, and the Bonus.
 - 2) If you wish to withdraw your profits and deposit amount **before** having completed the trading requirement of 20 times of your deposit amount, **the full amount of your bonus** will be cancelled and removed from your Binary account, and you may then withdraw the rest of your remaining balance including your Profits and Deposit.

For example:

You make a deposit of \$100 and receive \$50 as a 50% deposit bonus, and you wish to withdraw your deposit amount. You may withdraw your deposit amount, but the deposit bonus of \$50 will be removed from your Binary account unless you have completed (20 x 100 = \$2,000) trading volume.

Q. What will happen if I have made a deposit and received a 50% deposit bonus during the campaign period and then made another deposit? What will be my withdrawal conditions?

10. The account balance at the time of your making the second deposit will be checked whether it is less than \$1 (£1).

If you make a deposit and receive a 50% Deposit Bonus and make another deposit, the trading requirements for the Deposit Bonus will be exempted only if:

The account balance at the time of your second deposit is less than \$1 (£1).

For example:

- 1) Make a deposit of \$100 and receive \$50 bonus.
- 2) Your Balance is \$150.
- 3) You make another deposit of \$100
- 4) At the time of you making the second deposit, your Balance is \$0.

- 5) Since it is less than \$1 the trading requirements for the Deposit Bonus will be exempted.

Removal of the Bonus

11. Please note that Hirose Financial MY reserves the right to remove the bonuses from your Binary Options account unless you have fulfilled the trading conditions stated under the Withdrawal Related Conditions within 2 months from the month in which you have made a deposit for the bonus.
12. This promotion cannot be offered together with our Signal campaign (<http://hiroseuk.com/cp/signal/>) or any other Deposit Bonuses. You can either receive a 50% deposit bonus or the Signals.
13. We reserve the right to exclude you from this promotion if we believe you have tried to benefit from fraudulent activities or your actions have breached any good faith of this promotion.
