50% Deposit Bonus Campaign
Terms and Conditions

1. In order to participate in the 50% Deposit Bonus Campaign you agree to be bound by these Terms as well as the general terms and conditions that apply to your Account. These Terms constitutes the entire Terms and extinguishes all previous Terms, promises, assurances, and understandings whether written or oral, relating to its subject matter.
2. You are required to be over eighteen (18) years old and have a Live Binary Options account with Hirose Financial UK.
3. We reserve the right to amend these Terms at any time without prior notification. Such amendments shall become effective and in force immediately upon being posted in this Terms section of our website. It is your responsibility to review the Terms on a regular basis (particularly in the end of a calendar month when we periodically update the Terms).

You will be notified of material changes to the Terms on Hirose News on the home page of our Website at <http://www.hiroseuk.com/> before they come into effect. Your continued use of the Site after a change or update has been made to the Terms will constitute your acceptance of such change or update.

4. This program will run from 00:00 GMT on 01st May 2017 until 24:00 GMT on 31st May 2017.

Bonus Credit Related Conditions

5. You will be entitled to a 50% deposit bonus when you make a deposit into your Binary Options account during the campaign period. The maximum bonus granted to you is \$1,000 (£1,000). Any amount of deposits over \$2,000 will be given a \$1,000 bonus. (A funds transfer from another trading account into your Binary Options account will be not be counted.)
6. *The 50% deposit bonus is available only for the first deposit during the campaign period.* From the second deposit during the campaign period, you will not be entitled to the 50% deposit bonus.
7. The 50% deposit bonus will not be given to you if you have made a withdrawal of any amount from your Binary Options account before we process the credit of the bonus.

How to Receive a Bonus

8. In order to receive a 50% Deposit Bonus you are required, during the campaign period to:
 - 1) Hold a LIVE Binary Options account with Hirose Financial UK. If you do not have the account, you can apply for the Live Binary Options account by filling in and submitting the account opening form along with the supporting documents.
 - 2) Fill in the Campaign Registration form and submit to us.

- 3) Make a deposit into your Binary Options account via Credit/Debit Card, Skrill, Neteller or Bank Wire. The minimum deposit for Credit/Debit Card, Skrill and Neteller is \$20 (£20) and Bank Wire is \$50 (£50).
- 4) The Bonus will be reflected to your account within 1-2 business days of a date you have made a deposit into your Binary Options account provided that you have already applied for the 50% deposit bonus by Campaign Registration Form.

Withdrawal Related Conditions

Q. Can I withdraw the bonus?

9. The Bonus can be withdrawn at any time after you have completed the trading requirement below.

Trading Requirement: 20 x Your Deposit Amount

For example:

You make a deposit of \$100 and receive \$50 as a 50% deposit bonus. You have completed (20 x \$100 = \$2,000) trading volume. Now you can withdraw the bonus at any time.

Q. Can I withdraw my profits and deposit amount?

10. Profits and your deposit amount can be withdrawn at any time. Please note the following conditions.
 - 1) If you wish to withdraw your profits and deposit amount **after** having completed the trading requirement of 20 times of your deposit amount, you will be able to withdraw all the funds including your Profits, Deposit, and the Bonus.
 - 2) If you wish to withdraw your profits and deposit amount **before** having completed the trading requirement of 20 times of your deposit amount, **the full amount of your bonus** will be cancelled and removed from your Binary account, and you may then withdraw the rest of your remaining balance including your Profits and Deposit.

For example:

You make a deposit of \$100 and receive \$50 as a 50% deposit bonus, and you wish to withdraw your deposit amount. You can withdraw your deposit amount, but the deposit bonus of \$50 will be removed from your Binary account unless you have completed (20 x 100 = \$2,000) trading volume.

Q. What will be my trading conditions if I have received a 50% deposit bonus at multiple times?

11. The account balance at the time of your making a deposit for the 50% deposit bonus will be checked whether it is less than \$2 (£2).

If you receive a 50% Deposit Bonus in the current and next month, the trading requirements for the first Deposit Bonus will be exempted only if:

The account balance at the time of your second deposit is less than \$2 (£2).

For example 1:

- 1) Make a deposit of \$100 in the first month and receive \$50 bonus.
- 2) Your Balance is \$150
- 3) You make a deposit of \$100 in the next month and receive \$50 Bonus.
- 4) At the time of you making the second deposit, your Balance is \$0.
- 5) Since it is less than \$2 the trading requirements for the first Deposit Bonus will be exempted which means your trading requirement is $20 \times \$100 = \$2,000$ (This does not include your first deposit amount).

For example 2:

- 1) Make deposit \$100 in the first month and receive \$50 bonus.
- 2) Your Balance is \$150
- 3) You make a deposit of \$100 in the next month and receive \$50 Bonus.
- 4) At the time of you making the second deposit, your Balance is \$50.
- 6) In this case the trading requirements for the first 50% Deposit Bonus will remain which means your trading requirement is $20 \times \$200 = \$4,000$ (This includes your first and second deposit amount).

Note: Even if you have completed the trading requirements for the first Deposit Bonus, you cannot withdraw the bonus if you have received another 50% deposit bonus before you withdraw the bonus.

For example 3:

- 1) Make deposit \$100 in the first month and receive \$50 bonus.
- 2) You have completed the trading requirements ($\$100 \times 20$).
- 3) Your Balance is now \$50 (This is now withdrawable).
- 4) You make another deposit of \$200 in the next month and receive \$100 Bonus.
- 5) At the time, 3) Balance \$50 is not withdrawable as you have received another deposit bonus of \$100.
- 6) In this case the new trading requirements for your bonus is $\$200 \times 20$ as you have already completed the first deposit bonus requirements.

Q. What will happen if I have made a deposit for a 50% deposit bonus and made another deposit without the 50% bonus? What would be my trading requirements?

12. Similar to Pt. 10 of the terms, the account balance at the time of your making a deposit will be checked whether it is less than \$2 (£2).

If you make a deposit and receive a 50% Deposit Bonus and make another deposit without the Deposit Bonus, the trading requirements for the Deposit Bonus will be exempted only if:

The account balance at the time of your second deposit is less than \$2 (£2).

For example:

- 1) Make a deposit of \$100 and receive \$50 bonus.
- 2) Your Balance is \$150.
- 3) You make a deposit of \$100 (without the Deposit Bonus)
- 4) At the time of you making the second deposit, your Balance is \$0.
- 5) Since it is less than \$2 the trading requirements for the Deposit Bonus will be exempted.

- ✘ When you have made a withdrawal, the conditions attached to the bonus will be cancelled.
- ✘ The same logic of calculation is applied when you have previously received any other deposit bonus including 100% and 120% deposit bonuses.

Removal of the Bonus

13. Please note that Hirose Financial UK reserves the right to remove the bonuses from your Binary Options account unless you have fulfilled the trading conditions stated under the Withdrawal Related Conditions within 2 months from the month in which you have made a deposit for the bonus.

- ✘ This removal conditions shall also apply to our previous Deposit Bonus Campaigns including “UP to 100% Deposit Bonus, Neteller Double Bonus Offer, and 100% Deposit Bonus.”

14. This promotion cannot be offered together with our Signal campaign (<http://www.hiroseuk.com/cp/signal/>) or any other Deposit Bonuses. You can either receive a 50% deposit bonus or the Signals.

15. We reserve the right to exclude you from this promotion if we believe you have tried to benefit from fraudulent activities or your actions have breached any good faith of this promotion.

20. The withdrawal conditions stated in Welcome Bonus Campaign Terms and Conditions will be exempted if you have received a 50% deposit bonus.

21. If these Terms and Conditions are translated into a foreign language then the English version shall prevail if any inconsistency exists.
